The meeting was called to order at 0400 pm – Sept 10, at Liberty Mountain Resort.

Presidents Report

Malcom Peterson welcomed everyone to the club and meeting. He asked all in attendance to introduce themselves to the group. Malcom Peterson then summarized the year and thanked everyone for their hard work and support. He remarked about the improvements to the web site; financial reporting and the successful tournaments that were conducted this year. As always, we are always looking to improve the way we do business.

Secretary report

Chris Pariseau reminded everyone that they had all seen the minutes from the previous meeting which were posted on the web site. He asked for a motion to accept the minutes as presented – a motion was made and a 2^{nd} was received. The president called for a vote. Minutes were approved unanimously by the members.

Vice President Report

Jeff Hild thanked the tournament chair for this years ABCD and 2 Man tournaments, He appreciated all the work that has been done to keep these tournaments viable events. There was extensive discussion about the location of the tournaments – how to improve – trophies etc.

Treasurer Report

Gary Manion presented an update of MISGA's finances for year to date.

Shown below is a self-explanatory schedule that identifies the 2019 Division Operations payments (a.k.a.: dues rebate) from the MISGA Treasury. The 2019 total Division Operations payout totals \$8,750, which equals the 2019 Board and Membership Approved Budget. At the time of writing this e-mail \$5,833 of the \$8,750 budget had yet to be paid out, but will be processed later this evening via the MISGA Sandy Spring Bank Account On-line bill payment system. The applicable Division Operations payments will be sent to the various Division Treasurer's in the same manner as the initial Division Operations payments that totaled \$2,917.

Also, worth mentioning is the 2019 Club Dues and Associates Dues actual payments. In 2019 MISGA collected \$2,150 in Club Dues (43 Clubs @ \$50 per Club) and \$21,800 in Associates Dues (2,180 Associates @ \$10 per Associate). Our 2019 Budget assumed we would collect \$1,950 in Club Dues (39 Clubs) and \$20,110 in Associates Dues (2,011 Associates). Hence, in 2019 there is a \$1,890 (8.5%) favorable revenue budget variance when these two revenue line items are combined.

Gary Manion recommended, that since the actual Associates Dues collected during the year is much greater than was anticipated in the 2019 Budget, Division Operations payments (for travel, trophies, golf entry fees, special events, meals, etc.) be increased by \$2,375 or the amount of the positive revenue variance. The recommendation was approved by the Board of Directors.

A few divisions had not submitted their Associates report to Jim as of the date of the board meeting.

Associates & Club Dues Checks – Associates Chairman Jim Wilcox recommended that, to avoid confusion and delays for Division Treasurers and the MISGA treasury, both the "Associated Dues" and "Club Dues" checks be transmitted direct to the MISGA Treasurer. The recommendation was approved by the Board of Directors

Audit Report – Errol Myers

Errol Myers presented two audits on two MISGA events – the 2019 Winter Fling held at Crystal River Florida March 2019 – and the 2018 Fall Frolic at Seabrook Island in October 2018. Copies of the reports are at the end of the minutes.

Discussion followed as to potential new locations – reducing the fees - changing start times etc. for both these events. It was also reported that:

Misappropriated 2019 Past Presidents (ABCD) Net Grand Champions Trophy – Tournament Chairman Greg Morris and Tournament Coordinator Jake Jacobi reported that while the Net Grand Champion was redeeming his monetary winnings in the Norbeck CC Pro Shop, his trophy had disappeared from its resting place on his dining table. It has never been found. Hence, both recommended that a replacement trophy be procured and presented to the Net Grand Champion. The recommendation was approved by the Board of Directors.
