

**2007 MISGA SEABROOK FALL FROLIC AT SEABROOK ISLAND, SC**  
**Sunday, October 28 (arrival)-Friday, November 2 (departure)**

The 2007 MISGA Fall Frolic will be held at Seabrook Island, SC. The club is located a few miles south of Charleston, SC, about a 10-hour drive from the Washington, DC area. **(1-800-777-8660)**. There are two excellent courses at Seabrook: Ocean Winds (designed by Willard Byrd) and Crooked Oaks (designed by Robert Trent Jones). Participation will be limited to 128 golfers or to the available accommodations. **Applications will not be accepted unless you are a MISGA member that has paid dues this year. ALL guests must provide a credit card** at check in.

Accommodations are individually owned villas furnished in a style selected by the owner and provide lodging for one, two, or three twosomes. **Please make up your own group to assure that you are with people you know.** The villas have a full kitchen, living room, dining area, washer & dryer and cable TV. Additional features include daily housekeeping

Daily competitions, Monday through Thursday, are planned for the men and the 18-hole and 9-hole ladies. Play will begin promptly with 9 a.m. shotgun starts. Ladies who only have a 9-hole handicap **will not** play with the 18-hole group. They will play with the 9-hole group and may have starting times later than 9a.m.

**THE EVENT PACKAGE INCLUDES:** Welcome reception including cocktail hour; Five (5) nights lodging (Sunday through Thursday); five (5) breakfasts (Monday through Friday); five (5) one hour cocktail parties; four (4) buffet dinners; the Thursday banquet plated dinner; four (4) days greens fees and cart rental and four days (4) bag storage and cart service. All taxes, gratuities and prizes are included. Gratuities for bellman, valet parkers & golf bag attendants are at each guest's discretion. **Lunch is not included** but is available during and after each round at each respective course.
