THE PRESIDENT'S CORNER

It is gratifying to state that MISGA is maturing. It is apparent that many of our learning processes are behind us, and we are confident that our future will demonstrate a controlled and smoother operation.

The control and management of our treasury has always been excellent. Expenditures have been accounted for to the penny; receipts have totalled precisely. The annual audits have invariably re-affirmed the precision of the treasurer's bookkeepping methods.

This year our new treasurer has re-arranged the system and instituted modern accounting techniques designed to furnish our officers with current data, and at the same time we have improved our overall control of expenditures. This will give us current, accurate and timely data during our operating summer months.

The MISGA board, looking toward the future passed a resolution that a reserve of \$5,000.00 be created and invested at interest. This money to be available on a contingency basis to avoid bankruptcy should we have a total washout of major tournaments for which we have made commitments for carts, food, motels, etc.. During 1982 we expect to reach this figure.

We anticipate a moderate increase in operating costs in 1981. Primarily because many of our functions must be put on a basis where the men who work so dedicatedly for us should be reimbursed for their out-of-pocket expenses.

This year the Executive Director has operating responsibilities for on-going MISGA affairs. His tournament director will be intimately and closely associated with each major tournament in-so-far as arrangements, protocol and format are concerned. His liaison director has launched an ambitious program to improve communications and the flow if information. Through the creation of seven local division representatives better local control is anticipated.

Under the direction and guidance of many dedicated men, the future pleasure of more and more Senior Maryland golfers is assured.

MISGA LIAISON COMMITTEE

LURPOSE

To establish an up and down channel of communication between the membership at large and the MISGA Board of Directors.

GOALS

To use every means possible to have and maintain a well-informed membership. To solicit new ideas from members as input to the MISGA Board. To identify clubs' members with special talent who may be available for MISGA administrative assignments. To encourage excellence by self-examination, then corrective action at Board and Club level.

DUTIES

Provide assistance and information to member clugs when requested.

Identify new clubs as potential MISGA members and help them to organize if asked.

Assist MISGA Tournament Chairman.

Distribute MISGA Associate cards.

Encourage sale of MISGA items.

PROCEDURE

Our member clubs will be broken up into units of 6 or less with a club representative as the primary liaison man. These units will be called Divisions, each headed by a Division Liaison representative who will be assisted by a Board member as an advisor. The Division liaison representative will in turn make contact with the Board through the MISGA Board Liaison Coordinator. Through this chain a continuous dialogue will be maintained from the members up and from the Board down.

The Liaison Committee chairman (coordinator) will meet twice yearly with each Division Liaison Representative in company with his club representatives. It is suggested that a meeting be held in October of each year to review the past season and solicit suggestions for next season. A second meeting should be held every June to review and assess the current year to date.

The Division Liaison Representative should touch base every month of the season with all of their club representatives by phone or in person. His findings should then be reported each month to the Liaison Committee Chairman by phone or mail. Any urgent matter should be reported immediately.

The Committee Chairman will refer any items received to the Executive Director for condiseration and action. Meanwhile, information will be flowing back through the same channel to the membership.

MISGA EVENTS: Notices of all events will be mailed to each Division Representative. He will contact each of his Club Representatives by telephone to ascertain:

- 1. Has the club representative received his copy of the notice?
- 2. Is the notice on display on the Senior's bulletin board?
- 3. Is the senior's telephone committee notifying MISA Associates about the event?
- 4. Determine number of participants from each Club and coordinate with the MISGA Events Chairman.

If the club representative is not available (sickness, traveling etc.) Make contact with the Assistant Club Representative and proceed as above with him.

A major objective for 1981 is to improve our communications, both publicity and at our clubs. Effective communications can strengthen and help MISGA grow, but more important, it can be most helpful to your club seniors program and make your members more appreciative of the benefits provided by both your club and MISGA. And in these days of increasing club dues and other costs, that can be very vital to your club from a membership standpoint, as well as enhance the enjoyment of your seniors get from golf.

Communications as it pertains to MISGA clubs has been pretty much a hit-or-miss thing. It ranges from virtually nothing at some clubs to a well planned and executed program at others. One reason may be that effective communications takes some imagination, planning and determination, mixed with artfulness, and dedicated people to carry it out.

The first thing you must do is make up your mind you are going to have good communications, appoint an interested chairman, and give him a good committee to work with.

Hereare some of the essentials of a good communications program:

- 1. See to it that the results of your Mixers and seniors tournaments get into the newspapers. All it takes is a phone call. This can be made by your pro, who normally has regular contacts with the papers. The call should be made early enough to meet their deadline. If you've followed golf news in the Washington Post and Star this past summer, you may have noticed that results of the University of Maryland's weekly seniors day tournaments appeared in the papers every Thursday without fail.
- 2. Within your club, one the first essentials is a seniors bulletin board for posting the seniors schedule, tournament results, clippings and notices, especially those regarding MISGA matters, such as the Mixer Schedule, Spring Fling, Major tournaments and the MISGA Associates program.
- 3. Regular notices in your club publication keeps those seniors who don't get to the club regularly informed of what they are missing and also makes other members aware of the fine seniors program they can look forward to in future years.

I am sure there are many other ideas being utilized which can be helpful to other clubs either as a special communication or through MISGAgram -- then we all can benefit from them. If we can help you, let us know.

Each year this tournament becomes more successful. MISGA's 36 club representatives were issued special invitations so that we could hold our Annual Meeting here the following day.

1981 GOALS AND OBJECTIVES

- 1. MIXER FORMAT: Frequently use the 2 man net best ball with 80% handicap and foursomes composed of A, B. C. D players in our MISGA Mixers. It is equitable for all players
- 2. CAR POOL: Make maximum use of car pools conserves feul & deepens friendships.
- 3. EQUITABLE STROKE-Review the handicap procedure at your club to assure that all scores are CONTROL (ESC): posted and that the equitable stroke control guidelines are understood & used.
- 4. MODIFIED SHOTGUN- To promote fellowship and speed play all Mixers should be run on a modified STRART: shotgun start basis.
- 5. SENIORS ON CLUB'S- Encourage Senior golfers to hold positions on their club's Board of BOARD OF DIRECTORS: Directors.
- 6. IMPROVE Establish a chairman for publicity and communications within each club. COMMUNICATIONS: Make more use of a senior's bulletin board, house organs, newspapers and most of all your telephone committee. Encourage on-going exchanges with the 7 Divisional representatives.
- 7. FELLOWSHIP: For the betterment and greater enjoyment of golf meet as many MISGA Associates as possible. This purpose is enhanced by serving coffee and donuts prior to play and everyone meeting for lunch after play.
